

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.csleathergoods.com and Crimson Serpents Outpost LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Crimson Serpents Outpost LLC include www.csleathergoods.com and Crimson Serpents Outpost. The Crimson Serpents Outpost website is a ecommerce site. By using the Crimson Serpents Outpost website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Crimson Serpents Outpost may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Crimson Serpents Outpost's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Crimson Serpents Outpost's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. Use of your Personal Information

Crimson Serpents Outpost collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Crimson Serpents Outpost may also use your personally identifiable information to inform you of other products or services available from Crimson Serpents Outpost and its affiliates.

Sharing Information with Third Parties

Crimson Serpents Outpost does not sell, rent or lease its customer lists to third parties.

Crimson Serpents Outpost may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Crimson Serpents Outpost. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Crimson Serpents Outpost website.

Use of Cookies

The Crimson Serpents Outpost website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server.
